The Stevens Amendment and DD Councils

November 2023

Background

Former Senator Ted Stevens once said that taxpayers "ought to be informed [about] how much money comes from federal sources in any program, project, or grant activity."

The purpose of the Stevens Amendment is to ensure transparency and accountability in federal spending.

Text of the amendment

When issuing statements, press releases, requests for proposals, bid solicitations and other documents describing projects or programs funded in whole or in part with Federal money, all non-federal entities receiving Federal funds, shall clearly state—

- (1) the percentage of the total costs of the program or project which will be financed with Federal money.
- (2) the dollar amount of Federal funds for the project or program; and
- (3) percentage and dollar amount of the total costs of the project or program that will be financed by non-governmental sources.

The general statement form:

The [project/publication/program/website, etc.] [is/was] supported by the [federal sub-agency] of the [federal agency] as part of an award totaling \$[insert your current grant award total amount here] with \$ amount, and % financed from non-governmental sources.

Requirement

DD Councils are required to acknowledge federal funding when publicly communicating about projects or programs funded through HHS federal financial assistance.

The statement is required when describing projects or programs funded in whole or in part with ACL funding.
